INDIAN SPRING GOLF COURSE GENERAL MEMBERSHIP AGREEMENT TERMS AND CONDITIONS

Membership Programs	<u>All membership programs are valid through December 31, 2021, absolutely no exceptions, including pro-rated rates.</u>
Validity	<u>Memberships are non-transferrable, non-negotiable, and are non refundable.</u> Memberships are solely for the Individual(s) registering. Anyone causing undue hardship to the golf staff attempting to obtain a lower rate than detailed in the Township Ordinance may be refused a membership.
Payment	If the final payment, along with this signed Agreement is not received, Indian Spring Golf Course is released from any and all obligations under this Agreement.
Resident Verification	<u>At the time of purchase, residents of Evesham Township will be required to show proof of residence.</u>
Age Verification	<u>At the time of purchase, applicants for Junior and Senior Golf Memberships will be required to show proof of age.</u>
Refusal of Privilege	Indian Spring Golf Course shall have the right to refuse golf course privileges to anyone who is judged to be in violation of the established rules and regulations herein. This includes but not limited to, failure to pay any and all applicable fees, theft of service, repeated no-show for tee times, negotiating membership rates, undue hardship to customers, fellow members and/or staff,
Registration	All players must register and sign in at the Golf Shop before play. Members are required to show their Membership Card (which is nontransferable). Golf play starts from the first tee unless advised otherwise by the Golf Shop.
Holidays	Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Thanksgiving, Black Friday
Golf Starting Times	Starting times may be obtained by via the Internet at indianspringgolf.com. <u>Tee Times are available up to 10 days in advance and are required.</u> <u>All members are required to have an online booking account.</u>
Tee Time Reservations	Indian Spring Golf Course reserves the right to pair all twosomes and threesomes. When reserving tee times, members are responsible for the number of players booked. Members who short show or no show will be subject to the prevailing public rate for each player. Groups that habitually no-show will be subject to member suspension.
Dress Code	Golfers are expected to wear proper golf attire on the course. Indian Spring Golf Course is a non-metal spike facility.
Pace of Play	<u>Players are expected to play in 4 hours and 15 minutes or less.</u>
Courteous Play	It is golfing etiquette to replace divots, repair ball marks on greens, rake smooth all marks made in sand traps and re move used tees from the teeing grounds.
Golf Carts	Cart rules will be posted daily in the Golf Shop or on the first tee and all players are expected to abide by these rules. Carts must be driven on cart paths only on all Par 3's and kept at least 20 feet from all Tees and Greens at all times. Roped off areas are off limits to carts. <u>Players must pair up on carts, maximum two carts per group.</u> <u>Single Rider carts will be required to pay an additional \$16 fee per round.</u> <u>Cart fees for non package holders are \$19 for 18 holes and \$11 for 9 holes.</u>
USGA Handicap	All Indian Spring Golf Course members receive complimentary USGA GHIN handicap.
Food & Beverage	Food and beverages are not permitted on the course unless purchased from Marco's restaurant. Private coolers containing alcohol are not permitted.
Limitation of Liability	Indian Spring Golf Course will not be liable for any lost profits or for any indirect, incidental, consequential, puni-tive or other special damages suffered by the player arising out of or related to this Agreement even if Indian Spring Golf Course has been advised of the possibility of such damages. In no event shall the total cumulative liability of Indian Spring Golf Course in connection with the Agreement from all causes of action of any kind (including tort, contract negligence, strict liability, breach warranty and fundamental breach) exceed the total amount paid by the player to Indian Spring Golf Course under this Agreement.
Indemnification	The player will defend, indemnify and hold Indian Spring Golf Course, together with the parent companies, subsidiar-ies and/or affiliated companies and the shareholders, officers, directors, partners, members, manager, employees, agents, consultants, representatives and attorneys of all foregoing and their respective heirs, executors, administrator .

7 Day Membership	unlimited play, anytime
Senior Memberships	unlimited play, Monday-Friday, weekends after 1pm during peak and flex seasons
Twilight Membership	unlimited play, everyday after 1pm
Cart Package	unlimited cart rentals for the year PER PERSON, only available with a membership package
Driving Range Membership	unlimited driving range balls for the individual member only, must be a golfing member
Junior Membership	unlimited play, anytime, ages 13-19, must have drivers license to take a cart
